

## **RENEWI TOUR PREDICTOR 2026**

### **CONTEST RULES**

#### **Article 1 – Organising company**

The **Renewi Tour Predictor** is organised by Golazo Sports NV and Renewi on behalf of the Renewi Tour. Participation in the competition is free of charge and implies full acceptance of these contest rules. The organiser reserves the right to modify these rules at any time, suspend the contest or cancel it in case of force majeure or circumstances beyond its control. Where reasonably possible, participants will be informed of such changes. The organiser cannot be held liable for any modification, suspension or cancellation of the competition, and participants shall not be entitled to any compensation.

#### **Article 2 – Participation**

The Renewi Tour Predictor is open exclusively to natural persons residing in Belgium. Participants must be at least 18 years old and legally capable of entering a competition. Participation is limited to **one entry per e-mail address per stage**. Participants may take part in one or several stage predictions during the Renewi Tour 2026, which takes place from **19 August 2026 until 23 August 2026**. The organiser reserves the right to exclude participants who do not comply with these rules or who attempt to manipulate, abuse or fraudulently influence the competition.

#### **Article 3 – How to participate**

Participation is free and without obligation. To participate, entrants must:

- Complete the required personal details.
- Predict the winner of the selected Renewi Tour stage.
- Correctly answer the additional competition question and tiebreaker question.
- Accept the contest rules.

Predictions must be submitted before the prediction deadline for the relevant stage. Late entries will not be considered. The organiser cannot be held liable for technical malfunctions, software problems, internet failures, server interruptions or any other circumstances that may prevent participation. Any attempt to influence the competition through automated systems, fake identities, multiple accounts, software manipulation or fraudulent participation may result in immediate exclusion. The organiser reserves the right to invalidate suspicious entries.

#### **Article 4 – Winners**

For each stage of the Renewi Tour, one or more winners may be selected from among the participants who correctly predicted the stage winner and correctly answered the additional competition question. If multiple participants provide the correct prediction and answer, the winner may be determined by a draw. The organiser's decision regarding the selection of winners is final and cannot be contested. Winners will be contacted personally by e-mail in the week following the Renewi Tour. If a winner cannot be reached within a reasonable timeframe or fails to respond, the organiser reserves the right to select an alternative winner.

#### **Article 5 – Prizes**

Participants have a chance to win various prizes, including but not limited to:

- Official signed Renewi Tour jerseys;
- VIP tickets for a future edition of the Renewi Tour;
- Partner gifts and promotional items;
- Other prizes determined by the organiser.

Prizes cannot be exchanged, transferred or redeemed for cash. The organiser reserves the right to replace a prize with an equivalent alternative should circumstances require this.

#### **Article 6 – Liability**

Except in cases of fraud, gross negligence or wilful misconduct, neither the organiser, its employees, partners, suppliers nor any third parties involved in the organisation of the competition can be held liable for any damage resulting directly or indirectly from participation in the competition, the selection of winners or the awarding of prizes. The organiser provides no guarantees regarding the availability, operation or uninterrupted access to the prediction platform. Typing errors, technical errors or omissions do not create any obligation on the organiser.

#### **Article 7 – Accessibility of the rules**

These contest rules are available at all times through the Renewi Tour Predictor platform and may also be requested from the organiser. Participation in the competition implies acceptance of these rules.

#### **Article 8 – Personal data**

By participating in the Renewi Tour Predictor, participants consent to the processing of their personal data by the organiser in accordance with applicable privacy legislation, including the General Data Protection Regulation (EU) 2016/679 (GDPR). The personal data collected may include:

- First name
- Last name
- E-mail address
- Company name (optional)
- Competition answers

These data will be used exclusively for:

- Managing the competition;
- Contacting winners;
- Prize administration;
- Statistical reporting related to the competition.

Participants have the right to access, rectify, limit, transfer or delete their personal data by submitting a written request to the organiser. Further information can be found in the official Renewi Tour privacy statement.

#### **Article 9 – Complaints**

Any complaint relating to the competition must be submitted in writing within **7 calendar days** following the end of the Renewi Tour 2026. Complaints received after this deadline will not be considered.

#### **Article 10 – Applicable law**

These contest rules are governed by Belgian law. Any dispute relating to the competition, its interpretation or implementation shall fall under the exclusive jurisdiction of the competent courts of Belgium.
